

Official South Jersey Federal Credit Union President's Day Auto Loan Promotion Rules ("Official Rules")

CONSUMER DISCLOSURE

You are not yet a winner. No purchase or payment of any kind is necessary to enter or win this "chance drawing." Grand Total Value of any one prize does not exceed \$500. Odds of winning depend on the number of eligible entries received. South Jersey Federal Credit Union **President's Day Auto Loan Promotion** (the "Prize Drawing") is sponsored by South Jersey Federal Credit Union, 1615 Hurffville Road, P.O. Box 5530, Deptford, NJ 08096 ("SJFCU"). SJFCU and its agents, together, hereinafter will be referred to as "SJFCU." Participating in the **President's Day Auto Loan Promotion** constitutes the entrant's ("you" or "your") full and unconditional agreement and acceptance of these Official Rules, including the decisions of the judges, which are final on all matters relating to the drawing.

- **1. No purchase is necessary to enter or win.** A purchase or transaction will not improve your chances of winning. Void where prohibited. No facsimile or mechanically reproduced entries allowed.
- 2. How to Enter: To enter the President's Day Auto Loan Promotion a person must apply for a new or used motor vehicle loan (excludes Recreational Vehicle ("RV") loans) between 2/10/2020 through 2/29/ 2020. Upon receipt of a *completed* loan application, you will automatically be included in the random drawings. A completed application is one that is fully executed, on an official SJFCU loan application with authorization to obtain your credit report. Application for a loan does not guarantee that a loan will be granted. Approval for loans take into considerations several different factors, such as credit score, credit history, loan to value, fair market value of vehicle, debt to income ratio, term of loan requested, and several other factors. Only one entry per person.

You may also enter by writing your name, address and phone number and the words **President's Day Auto Loan Promotion** on a 3" x 5" postcard and mailing it to SJFCU, 1615 Hurffville Road, P.O. Box 5530, Deptford, NJ 08096. Limit one entry per postcard. Only one entry per person. Mail-in entries must be postmarked and received by 11:59 pm on 2/29/2020. SJFCU assumes no responsibility for printing errors, lost, late, damaged, misdirected, illegible or incomplete entries. Entries void if defective, altered, forged, or obtained outside authorized channels. Contest ends at midnight on February 29, 2020. Winner will be notified by phone or mail.

- **3. Who Can Enter:** The Drawing is open to any member of SJFCU in good standing 18 or older who enters following the requirements. Employees and board members of SJFCU, their spouses and immediate family members, volunteers, agents and contractors are not eligible to enter.
- **4. Prize Details:** Three winners will be randomly drawn from all members who apply and sent in a postcard during the contest period. The first prize is one \$500 Visa Gift card, the second prize is one 50-inch Smart TV, valued at \$300, and the third prize is one \$250 gift card for the Borgata hotel. All taxes on prizes, and all other expenses not specified herein, are the responsibility of the winner. It is the responsibility of the winner to report any winnings as income to the IRS. Prizes are non-transferable. No substitutions.
- **5. Drawing Date; Selection of Winners:** The **President's Day Auto Loan Promotion** drawings will take place on March 16, 2020, at Noon at the corporate office of SJFCU at the address provided above. Random drawing to select one winner will be made from among all eligible entries received. Judges' decisions are final.
- **6. Notification and Redemption:** If you are drawn as the winner, SJFCU will attempt to notify you via mail, email and/or phone after the drawing. If the winner does not respond within 72 hours or declines the prize, another winner will be randomly chosen. You will be invited to the main office of SJFCU to receive your prize. Prize is non-transferable and official photo identification (driver's license, passport, etc.) must be presented to receive your prize. In the event of noncompliance with these Official Rules, or if prize notification is undeliverable, prize will be forfeited and an alternate winner will be randomly selected.
- 7. Odds of Winning: Odds of winning depend on the total number of eligible entries determined at the time of drawing.
- **8.** Use of Entrant and Winner Information: The information that you provide in connection with the Drawing may be used by the Credit Union to send you information about its products and services. If you would like your information removed from the Credit Union's mailing list, if you do not wish to receive information from the Credit Union or if you would like to be removed from the Credit Union's mailings regarding this promotion, write to SJFCU at 1615 Hurffville Road, P.O. Box 5530, Deptford, NJ 08096. SJFCU will process your request within 60 days.
